





During mandatory stay-at-home orders, we were unable to meet with our friends in person but found a way to keep in touch through a series of virtual events as well as an enhanced social media presence where friends and supporters could easily access our content.

I'm pleased to share some highlights in our **2020 Annual Report** — "Light the Way to Liberty." Through the following initiatives, among others, we provided a beacon of clarity during a time of challenge:

- **Curbing big government during a crisis** Our scholars and research fellows in economics, healthcare, education, and civil rights were at the forefront of research and commentary.
- Inspiring the next generation for liberty Our award-winning *Love Gov* video series continued to reach young people and achieved over 10 million views this year and total views of 35.5 million since it launched.
- Preserving opportunity as unemployment spiked The economic fallout from COVID-19 results in millions of people losing their jobs. The government even focused on taking away opportunities for independent contractors by banning "gig economy" workers. We took strong and decisive action to curtail this legislation by actively seeking a suspension of a disastrous California assembly bill as well as submitting two amicus briefs before the U.S. Court of Appeals for the Ninth Circuit.
- Expanding housing affordability Our Center on Entrepreneurial Innovation released an *Independent Policy Briefing*, "How to Restore the California Dream: Removing Obstacles to Fast and Affordable Housing" (part of our California Golden Fleece Award® series).
- **Securing quality education** Improving K-12 academic standards and schools was the focus of our Center for Educational Excellence through in-depth policy reports and briefings, especially to fight the capitalism-is-racism message of proposed curricula in "ethnic studies."

We are profoundly grateful for your support and are proud to join together in our common goal to ensure the dignity of liberty for all.




# Freedom and Prosperity During a Global Pandemic

COVID-19 and the economic fallout from the lock-downs have thrown millions of people out of work and in need of flexible employment opportunities. Unfortunately, policies of regulating and reducing the use of independent contractors are blocking these people from the "gig economy" jobs they need.

In California, this centers on Assembly Bill-5 (AB-5) which bans independent contractors and has the potential under President Joe Biden for nationwide adoptions. The Independent Institute has boldly resisted these regulations and preserved employment through:


# The Independent Review: A Journal of Political Economy




### Fixing Science: Practical Solutions for the Irreproducibility Crisis




### Virtual Events ... Real Connections

















# Supporter Spotlight

### Personal and Professional Background and Philanthropic Giving

Don is a Sonoma County native. He has been happily married to his wife, Nancy, for over 45 years and they are blessed with three children and nine grand-children—all living within a nine-block radius. After having inherited his father and grandfather's wine-making experience and business, Don is now grateful to see his children continue the Sebastiani legacy. His son Donny now leads Don Sebastiani & Sons, a leading producer of fine wines, first-rate spirits, and sparkling water. His son, August, owns a successful beverage label and recently opened a tasting room in Sonoma's historic town center fire station. His daughter, Mia, has expanded into the food industry with her "Mia's Kitchen" Italian sauces label.

In addition to the Independent Institute, Don is proud to support his local parish and many different community groups in the Sonoma Valley. Mentoring teenagers is a deep passion for him and something he has been involved in for over 30 years, both in the Haight-Ashbury district of San Francisco and in Sonoma.

#### **Political Values**

This journal's conservative ideas were formative, and he decided to run for the California State Assembly, in which he held office for three terms.

Don cares very strongly about parental choice in education. He is a critic of public schools, school systems, and teachers' unions attempts to wrestle childrearing responsibilities from parents. "They act like they are entitled to manufacture children in their image, but such is the due responsibility of parents themselves," says Don.

"Although I retired in 2019, I remain involved as a shareholder and Chairman of the Board. Outside of Yancey Bros. Co., I continue to be active in investing in a broad portfolio of start-up companies in healthcare, agricultural technology, manufacturing, and other industries. Happily, in business, I am still learning and growing.

"Much of my philanthropic giving stays local. I support and serve on the Board of the Shepherd Center, a spinal injury rehabilitation hospital in Atlanta, and the Wesleyan School, a private K-12 school outside of Atlanta, which my children attended. Nationally, I have served on the Board of Directors for Americans for Prosperity and have supported the Boy Scouts of America."

#### The Lighthouse Logo

**The Independent Institute's lighthouse logo** was inspired by 1991 Nobel laureate Ronald Coase's renowned 1974 essay in the *Journal of Law and Economics*, "The Lighthouse in Economics" (reprinted in the book, *The Firm, the Market and the Law*, by Ronald Coase).

Until that time, conventional wisdom from John Stuart Mill to Paul A. Samuelson held that the lighthouse was the quintessential "public good," which allegedly had to be provided by government due to the inherent free-riding of those who could not be charged for the services being provided.

Coase showed, however, that in Britain, "contrary to the belief of many economists, a lighthouse service can be provided by private enterprise. The lighthouses were built, operated, financed, and owned by private individuals, who could sell a lighthouse or dispose of it by bequest. The role of the government was limited to the establishment and enforcement of property rights in the lighthouse." Only later did the British government consolidate all lighthouse services under its own monopoly in order to eliminate competition and directly reap the financial benefits developed by private entrepreneurs.

In addition to exposing the fallacies of a favorite public-goods rationalization, Coase's essay rescued the lighthouse as a symbol of courage, enlightenment, and independence.
